Covenant Keepers K9 Training Facility Policies & Legal Stuff * Please Read and Initial Each Section *****

1. ___ Covenant Keepers K9 Training Facility reserves the right to immediately change your pet's type of boarding or daycare if we believe it is necessary to protect the health and well-being of your pet, other pets, or our staff, and Owner agrees to pay any additional costs associated with the change.
2. ___ Owner is aware and agrees dog will be put into a crate/kennel on a regular basis and is where he/she will sleep at night.
3. ___ Owner agrees to pay all costs and charges for special services requested, and provide updated vaccination records from your vet before starting daycare or boarding.
4. ___ Owner agrees that the pet shall not leave the kennel until all charges are paid in full to Covenant Keepers K9 Training Facility.
5. ___ Owner agrees to be solely responsible for any and all acts or behavior of Owner's pet while it is in the care of Covenant Keepers K9 Training Facility.
6. ___ Owner specifically represents that they are the lawful and valid owner of the pet, free and clear of all liens and encumbrances.
7. ___ Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
8. ___ Owner agrees that in the event the boarding charges are not paid when due in accordance with this agreement, Covenant Keepers K9 Training Facility may exercise its lawful rights upon ten (10) days written notice by delivering such notice via first-class mail to Owner's Address. A pet that is unclaimed at Covenant Keepers K9 Training Facility for ten (10) days beyond its scheduled discharge date is considered abandoned and will become the property of Covenant Keepers K9 Training Facility. Every effort will be made to contact Owner if abandonment becomes an issue. If for any reason the pet is not going to be picked up on the scheduled dismissal date, Owner shall contact Covenant Keepers K9 Training Facility to make arrangements to extend the animal's stay and will pay the additional charges based upon the aforesaid daily rate.
9. ___ If the pet becomes ill or if the state of the animal's health otherwise requires attention, Covenant Keepers K9 Training Facility at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$500.00 or _____, whichever is greater. If a veterinarian determines that emergency treatment, which Exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal. I understand that even with vaccinations, illnesses in dogs may occur. Particularly, I understand that even if my dog is vaccinated for Bordetella (commonly known as Kennel Cough) there is a chance that my dog can still contract Kennel Cough. I agree that Covenant Keeper's K9 Training Facility will not be responsible if my dog becomes ill, including if my dog contracts Kennel Cough.
10. ___ Veterinary Care: In the event my dog becomes ill or sustains injury, I have given permission for those in charge to take whatever steps are necessary to obtain medical treatment for my dog. I am giving Covenant Keeper's K9 Training Facility the right to make medical decisions on my behalf if I, or my emergency contact, cannot be reached or cannot respond with a decision within 3 to 6 hours or possibly less time if 3 hours is not feasible. I consent to Black Canyon Veterinary Hospital and/ or a Pet Emergency Hospital being chosen to render care for my dog and I agree that I will hold them completely harmless and not liable

for any injury, illness, death, or loss of my dog while they are administering whatever treatment they feel necessary to recover the health of my dog. I will pay the full amount of all charges associated with the medical treatment given to my dog by Black Canyon Veterinarians or any Emergency Veterinarians at, or before the time of picking up my dog. Possible After Hours or Emergency Medical Needs: I authorize and hold harmless any available Covenant Keeper's K9 Training Facility employee to transport my dog to Any Pet Emergency Hospital to receive "after hour" care if the Covenant Keeper's K9 Training Facility staff agrees that the health situation should not wait until the next day to be treated. I authorize the Covenant Keeper's K9 Training Facility employee to sign the hospital's waiver/contract on my behalf in order for the emergency hospital to begin treating my dog.

In a life or death situation that requires a decision to be made, unless I have left Covenant Keeper's K9 Training Facility with a written statement saying otherwise then I agree with the following: "If myself or my emergency contact, have not been able to be reached for a decision in time, I authorize the veterinarian attending to my dog to take any steps necessary in order to attempt to save my dog's life. I alone am responsible for and will promptly pay the hospital for all fees due during/after treating my dog.

11. ___ If my dog dies while in the custody of Covenant Keeper's K9 Training Facility, we will use reasonable efforts to notify me as soon as possible. Covenant Keeper's K9 Training Facility will take my dog's body to my veterinarian if it is reasonably convenient to do so; otherwise, Covenant Keeper's K9 Training Facility may take my dog's body to the nearest animal hospital. Owner agrees to pay any veterinarian expenses immediately upon demand.

12. ___ It is expressly agreed by Owner and Covenant Keepers K9 Training Facility that Covenant Keepers K9 Training Facility liability in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$200.00, whichever is less.

13. ___ Owner agrees to release, indemnify, and hold harmless Covenant Keepers K9 Training Facility from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to Covenant Keepers K9 Training Facility services, except which may arise from the gross negligence or intentional and willful misconduct of Covenant Keepers K9 Training Facility including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Covenant Keepers K9 Training Facility (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

14. ___ This Agreement shall be governed by and construed in accordance with the laws of the State of Colorado.

Each party consents to the exclusive personal jurisdiction of the state and federal courts of Colorado. Owner and Covenant Keepers K9 Training Facility must negotiate and mediate in good faith prior to either party filing a cause of action.

15. ___ Force Majeure. Neither Owner nor Covenant Keepers K9 Training Facility shall be responsible for failure or delay in performing its duties under this Agreement if such failure or delay is due to tornados, thunderstorms, fire, floods, drought, riot, war or other acts of nature.

16. ___ Words "you" and "your" refers to the Owner. Conversely, "We" and "our" refers to Covenant Keepers K9 Training Facility. Owner and Covenant Keepers K9 Training Facility may collectively be referred to as "the parties", and singularly as a "party".

17. ___ Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of Owner and Covenant Keepers K9 Training Facility.

18. ___ Loss of Personal Property:

We cannot be responsible for the loss of your dog's property while they are here boarding or property that you bring in to the dog park. There are too many scenarios to list here as to how your property could get lost or damaged by your own dog or someone else's. We promise to do our best to get it back to you in the same condition you brought it in but we cannot guarantee that. If it's that valuable, you probably shouldn't bring it.

19.____ The undersigned for and in consideration of the Grooming services at Covenant Keeper's K9 Training Facility: agrees to save and hold harmless Covenant Keeper's K9 Training Facility and its owners, operators, employees, officers, volunteers, and directors from any damage, loss or claims, accidental death of pet of the nature of pre-existing health condition, stress or natural disasters (Fire, Storm, Floods, Etc.).

The undersigned for and in consideration of the Grooming services at Covenant Keeper's K9 Training Facility will not be held responsible for clipper burns and / or minor nicks resulting from grooming matted, neglected coats or for irritation caused by removing coat from pets possessing mild to severe skin allergy, nor will we be held responsible for stressful effects grooming may have upon your pet, whether they be young or elderly.

20.____ The undersigned for and in consideration of Dogs not and/or familiar with Covenant Keeper's K9 Training Facility may experience separation anxiety when apart from their human companions. This may lead to a lack of appetite and some dogs may not eat for a few days. In this event a dog could loose weight and/or not eat all food provided for their stay. In this case Covenant Keeper's K9 Training Facility will do what they can to encourage your dog to eat or leave food accessible.

I recognize the risk of injury to dogs in playgroups/commingling (boarding, training, day care, grooming) even when directly supervised. I authorize my dog to interact, under direct human supervision, with other dogs.

ATTENTION ALL PUPPY OWNERS – If your dog is here for training:

-Training will be done by Covenant Keeper's Trainer for a total of 1-8 months (Depending on the package of your choosing).

-There is no guarantee your puppy will be 100% potty trained.

- Your puppy will know and demonstrate: on and off leash etiquette, all basic obedience, crate trained, potty trained, socialized (people, places, kids, animals) ect.

- Your puppy will be completely ready for Veterinarian and Groomer visits/stays

-Your puppy will come with all health/vaccine records.

-All feeding, boarding, and care will be provided by Covenant Keeper's K9 Training Facility

-If for any reason your puppy is injured while in our care- Covenant Keeper's K9 Training Facility will take full responsibility for cost of injury/vet bills.

-Your puppy will have a great base but your puppy is still a puppy and the commands will need to be conditioned throughout its life.

-If your puppy has a genetic health issue or genetic behavior issues that appear in growth that affect the training while in our care----you will be notified & Covenant Keeper's K9 Training Facility will NOT be responsible!

-Keep in mind all puppies will differ in personalities and genetic traits.

-You will receive a one on one training class with the trainers upon delivery. We will also provide you with a training video of your puppy.

-You will receive a lifetime of support from us- Covenant Keeper's K9 Training Facility!

-If you are dissatisfied with the results of your puppy's training- you have up to 30 DAYS FROM DELIVERY DATE- to notify Covenant Keeper's K9 Training Facility. After that point it is no longer Covenant Keeper's K9 Training Facility responsibility

Bark Collar & Training Collars

I only use non-aggressive, force free training methods based upon the science of behavior and behavior change. These force free methods are recommended by educated Veterinarians and Veterinary Behaviorists, American Animal Hospital Association, American Veterinary Medical Association, American Veterinary Society of Animal Behavior, and modern dog trainers like myself.

As such, I do not permit the use of choke, prong, when your dog is in my care. I also do not permit the use of dominance-based training, including knee jabs, scruff shakes, side kicks, alpha rolls, spray bottles or any other forceful, painful or aggressive training methods. Shock devices can be considered as a aversive 'training' tool and are not typically recommended for effective behavior change and modification. That being said sometimes the use of a bark collar or training collar may be needed. By signing bellow you agree to the use of either.

Safety and setting up success for you and your pet is of utmost importance. We follow common sense and recommended guidelines.

The more time dedicate to working with your pet, the more successful we will be. I can teach and advise, BUT I CANNOT DO THE TRAINING FOR YOU. Success in training reflects the time and effort you put into the process.
